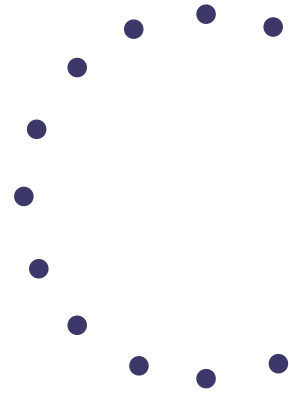

The Illinois Public Health Association (IPHA) is the oldest and largest public health association in the State of Illinois. As one of the largest affiliates of the American Public Health Association, IPHA is widely recognized as a leader in the field of public health advocacy, health education, and public health programming.

IPHA was established as a membership organization more than 80 years ago to engage public health practitioners and local health departments in a wide range of capacity-building activities to promote public health.

IPHA supports nearly 100 affiliated organizations—including county and local public health departments—in providing essential services to assure and improve health and wellness among 13 million Illinois residents. These services benefit virtually all residents and include immunizations, mother and child care, food and water safety, early warnings of virus outbreaks, and much more.

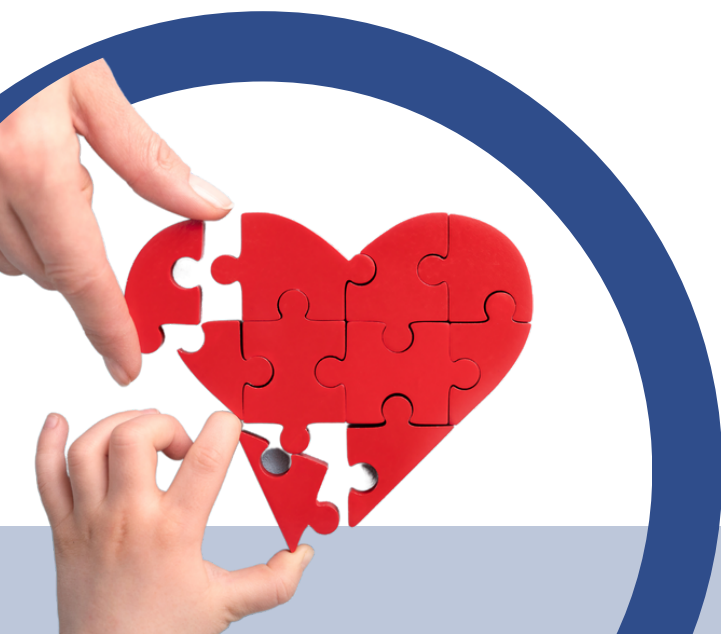
